The book provides an overview of standardized tools for assessing personality traits and attitudes that may be related to jurors' verdicts as well as the research establishing the validity of these measures. The authors review the studies that evaluate the effectiveness of both traditional and scientific methods of jury selection, including the methods used to conduct a community survey to guide a change of venue motion and the selection of potential jurors to excuse. Kovera and Cutler also discuss the ethical principles to be followed when assisting attorneys with jury selection issues.
